

What is CREATE?

A \$4.6 billion Public-Private Partnership (PPP) to improve transportation through the Chicago region by:

- Increasing capacity, speed and reliability for freight train traffic
- Separating freight and commuter trains at 6 key junctions
- Eliminating 25 road/rail grade crossings through grade separations



CREATE is a cooperative program among:

- U.S. Dept. of Transportation (FHWA & FRA)
- Illinois Dept. of Transportation (IDOT)
- Cook County Dept. of Transportation and Highways (DOTH)
- Chicago Dept. of Transportation (CDOT)
- 6 major North American freight rail carriers and 2 switching railroads
- 2 passenger carriers (Amtrak and Metra)




































CREATE Program 70 Projects

- 25 road/rail grade separations
- 6 passenger/freight rail grade separations
- Railroad projects to improve rail infrastructure and upgrade technologies
- Viaduct improvement program
- Grade crossing safety enhancements
- Rail operations and visibility improvements








75th St. CIP Details and Status



2018 INFRA Grant Award – 75th St. CIP

The **\$132 million** federal Infrastructure for Rebuilding America (INFRA) Grant closed a funding gap to push the next phase of this project toward the finish line

A total of **\$474 million** in funding will design the entire 75th St. CIP (P3, GS19, P2, EW2), construct two 75th St. CIP projects (P3, GS19) and construct the Argo Connections (B9)




Trains delayed



RAILROAD WORKFORCE DEVELOPMENT PILOT PROGRAM

CSX Railroad in partnership with Richard J. Daley Community College will offer a virtual technical course titled 4.0-Introduction to Mechatronics to residents who reside within 60620, 60629, 60636, and 60652. The virtual classes include training on the basics of safety, hand tools, measurement, blueprint reading, pneumatics, control circuits and robotics. At the end, participants can test to attain a certification for Smart Automation Certification Alliance (SACA) C-101 Certified Industry 4.0 Associate – Basic Operations – Silver Level (no hands on), an industry recognized credential. Course includes modules taught by CSX industry experts.

- Must work with community partners to complete vour customized skills assessments.

- Available to complete thirteen-week paid program.

- 11 completed in 2015–2016





DBE Participation Requirements

- Federally funded CREATE projects require certified Disadvantaged Business Enterprise (DBE) involvement
- Illinois Unified Certification Program (IL UCP) is one-stop process to become a certified DBE
- Typically, CREATE projects have 15% -30% DBE participation
- IDOT staff will be speaking more on this during tomorrow's Public Agency Panel from 10am - 12pm

Highway Construction Careers Training Program

- IDOT pre-apprenticeship training program, Dawson Technical Institute provides construction training and skill-improvement opportunities in all phases of the heavy civil construction industry
- Contractors participating in the program are reimbursed at \$15.00 per hour for training given a certified graduate trainee on CREATE Projects
- Graduates of the program being linked with job opportunities, such as Miguel A., who has been sponsored for Local 5 Laborers by Dyer Construction







Norfolk Southern Highlights





- Supporting adult digital literacy with \$10,000 donation to Hope Technology and Education Center in West Englewood
- Multi-year partnership with Chicago Public Library Foundation supporting the Teacher in the Library, Summer Learning Challenge, Science Connection and CyberNavigator programs


